# Professional Background

Matthew has been working on historic building repair projects since 2007, at three different specialist architectural practices. He has always had a passion for old buildings, and worked on a wide range of historic buildings, from medieval houses to 1930s churches. He has worked on a number of high-profile buildings such as the Tower of London, Chiswick House and the Victoria & Albert Museum. He has experience of working alongside new-build practices and has advised specialist consultants on working with historic buildings.

He undertook his RIBA parts I and II at Sheffield and Brighton universities. His Part II major project looked at the relationship between people, architecture and death in London. He subsequently studied at the Architectural Association for his post graduate diploma in building conservation, where his thesis focused on 17th century church repairs. Matthew is currently a career mentor for architecture students at Sheffield University.

Roles and Responsibilities

Matthew's project roles have included building surveys, condition surveys, contract administration, and technical drawings. He has undertaken Quinquennial Inspections, written specifications, methodologies and Heritage Statements. He has worked alongside colleagues to oversee the preparation of competition entries and tenders. Within the office, Matthew helped develop and maintain our company website, as well as undertaking a range of general administrative duties. He is proficient in AutoCAD, Microsoft Office, the Adobe suite and the NBS software.

He has undertaken historic research into a variety of buildings, which has fed into design proposals, or been used to help understand a building's significance and development.
